### 2. Aelod Pwyllgor Cymunedol Newydd

2.1 Bydd aelodau'n cofio ail-benodi dau o'r aelodau annibynnol a phenodi tri aelod etholedig o'r Cyngor i'r Pwyllgor Safonau yn ddiweddar. Yn ogystal â'r seddi hynny, mae angen penodi 'Aelod Pwyllgor Cymunedol' newydd, ac felly ysgrifennais at glercod yr holl gynghorau yn gofyn am enwebiadau. Y bwriad oedd cynnal cyfweliadau o flaen panel o aelodau'r Pwyllgor Safonau, a chyflwyno argymhelliad i'r Cyngor, sydd â'r hawl i benodi. Derbyniwyd dau enw ond tynnodd un yn ôl ar y funud olaf. Felly, yn dilyn ystyriaeth o'i ffurflen gais am y swydd yn erbyn y meini prawf perthnasol, mae'r panel penodi yn argymell i'r Cyngor benodi'r Cyng. David Clay o Gyngor Tref Abermaw, i wasanaethu ar y Pwyllgor Safonau.

### 1. Background

1.1 There are eight members on the Standards Committee, three elected members from Gwynedd Council, four 'Independent Members', and one 'Community Committee Member' who is a member of a community/town council within Gwynedd, but not a member of Gwynedd Council.

# 2. New Community Committee Member

2.1 Members will recall re-appointing two of the independent members and appointing three elected members from the Council to the Standards Committee recently. In addition to those appointments, a new community committee member is also required, and therefore, I wrote to all the community councils asking for nominations. The intention was for a panel of members from the Standards Committee to interview the applicants and make a recommendation to the Council, which has the power to make the appointment. Two applications were received, but one of the applicants withdrew at the last moment. Therefore, after considering his application form, in light of the appropriate criteria, the appointment panel recommends that the Council appoints Cllr, David Clay of Barmouth Town Council to serve on the Standards Committee.

#### 3. Recommendations

3.1 To appoint Councillor Ashley Michael David Clay to serve as the Community Committee Member of the Standards Committee for a period of four years or until the next ordinary elections for community councils, whichever is the shorter.
