13 NOTICE OF MOTION

In accordance with the notice of motion received under Procedural Rule 13, Councillor Gwilym Euros Roberts will propose as follows:-

"Due to cuts in Home Office funding all indications show that there will be cuts to front line policing in Gwynedd from next April.

This Council calls for an urgent meeting with the Chief Constable of North Wales Police and the Chairman of North Wales Police Authority in order to find out exactly what this will mean in terms of police numbers and

capacity in Gwynedd for policing and in particular the rural communities within the County."

The procedural motion was also received from the member in accordance with Procedural Rule 13(12) requesting that the matter be discussed on the day instead of being referred to the relevant committee.

14 REPORTING BACK ON PREVIOUS NOTICES OF MOTION

To report for information that:-

- (a) the Council at its meeting on 17 June 2008, adopted a notice of motion objecting to the proposed change to the provision of special education in the County, and the motion was referred to the Council Board.
- (b) the matter was considered by the Board on 8 July 2008, and resolved as follows:-
 - (i) *to close the Special Educational Needs Units at Ysgol Glan Cegin and Dolgellau, in accordance with the Head of Service's report;*
 - (ii) *to continue with the other current arrangements for the time being and to open the twelve other special educational needs units for five mornings a week;*
 - (iii) *to re-convene the Working Group that had been considering the matter with three elected members of the Children and Young People Scrutiny Committee serving on it;*
 - (iv) *that the Working Group considers extending its membership so that it is possible to include the comprehensive opinion of users, parents and other additional representatives from among the units' teachers and heads;*
 - (v) *that the Working Group considers the broad range of all fields of Special Educational Needs in the County, giving detailed attention to important principles such as integration, inclusion, achievement, quality and value for money;*
 - (vi) *that the Working Group consults extensively on possible options;*
 - (vii) *that the Schools Service adheres to its savings target and achieves the relevant financial savings from elsewhere in 2008/09.*

It was also resolved that that the Head of Schools Service sends a letter to the parents to apologise for the concern caused to them as a result of the plan.
