You will recall that this Committee approved minor changes to the wording of the Hackney / Private Hire Vehicles Licensing Policy to update it, so that it coincided with current taxi licensing administration processing arrangements. Since approving the policy on the 15 September 2014, it has become apparent that the words 'change of vehicle' appears in clause 3, part C page 4 of the Policy incorrectly.
