1. CAIS A DDERBYNIWYD

- 1.1 Atodir cais am drwydded eiddo ar gyfer Land and Seafood Bar, yr ardal tu allan i'r Abersoch Land and Sea, Royal Garage , Abersoch, LL53 7AH, gan Zobra Limited; o Manchester Hall, 36 Bridge Street, Manceinion. Mae'r ymgeisydd yn ceisio trwydded eiddo ar gyfer bwyty tu allan i adeilad busnes gwerthu a thrwsio cychod Abersoch Land and Sea. Fe ddangosir lleoliad y llecyn trwyddedig arfaethedig ar Gynllun 1 a atodir gyda'r cais. Mae Cynllun 2 yn dangos lleoliad y fan arlwyyo 'airstream' lle bwriedir gweini bwyd a diod i gwsmeriaid ar y byrddau a chadeiriau sydd wedi eu gosod eisoes yn y lleoliad. Mae Cynllun 3 yn dangos lleoliad y toiledau ar y safle. Gofynnir am yr hawl i werthu alcohol o 11 y bore tan 21:30 yr hwyr, ar ac oddi ar yr eiddo; saith diwrnod yr wythnos , ac fe ofynnir am hanner awr yn ychwanegol er mwyn rhoi cyfle i gwsmeriaid orffen a gadael.
- 1.2 Ni wneir cais am yr hawl i gynnal adloniant; ond petai y drwydded yn cael ei chaniatáu; fe fyddai'r ymgeisydd yn gallu manteisio ar eithriadau y Deddf Cerddoriaeth Fyw 2012 i chwarae cerddoriaeth chwyddiedig tan amser cau am 22:00.
- 1.3 Mae swyddogion yr Awdurdod Trwyddedu yn fodlon fod tystiolaeth ddigonol fod y cais wedi ei gyflwyno yn unol â gofynion y Ddeddf Drwyddedu 2003 a'r rheoliadau perthnasol ac felly yn ddilys.

- Ni fydd cynnwys biniau yn cael eu trosglwyddo i sgipiau rhwng 23:00 a 07:00 y bore
- Fe weithredir Polisi 'Her 25'
- Hyfforddiant i staff ar werthiant o dan oed
- Arddangos Rhybuddion ar ba fath o gardiau adnabod sy'n dderbyniol
- Arddangos rhybuddion mewn llefydd amlwg yn nodi fod Polisi 'Her 25' yn cael ei weithredu

3.2 Sylwadau Heddlu Gogledd Cymru

- 3.3 Mae'r Heddlu yn datgan pryder ynglŷn a gallu'r ymgeisydd yn benodol i sicrhau cydymffurfiaeth gyda'r pedwar amcan trwyddedu , ond yn benodol gyda'r amcanion o sicrhau diogelwch y cyhoedd a gwarchod plant rhag niwed. Noder nad yw y ffens rhaffau sydd wedi eu gosod i amgylchynu'r ardal eistedd yn rwystr digonol i sicrhau gwahaniad digonol rhwng yr ardal fwyta a gweddill gweithgareddau busnes cychod Land and Sea.
- 3.4 Mae Tractors a cychod yn mynd i fod yn atyniad naturiol i blant chwilfrydig ac nid yw y rhaffau yn mynd i rwystro plentyn rhag camu i lwybr tractor
- 3.5 Mae alcohol yn effeithio ar allu oedolion i i farnu pellter a chyflymder cerbydau , ac mae yn lleoliad yr ardal fwyd mor agos i'r ffordd brysur a busnes cychod

3.6 Sylwadau Uned Rheolaeth Datblygu Cynllunio Cyngor Gwynedd

- 3.7 Fe dderbyniwyd sylwadau yn nodi fod Caniatâd Cynllunio eisoes wedi ei wrthod ar gyfer datblygiad cyffelyb ar y safle yn 2021. (cais rhif C21/0140/39/LL) Fe nododd y swyddog fod y datblygiad diweddaraf ar yr eiddo yn ei hanfod yr un peth a wrthodwyd yn 2021; ac o ganlyniad nid oes hawl wedi ei sefydlu ar gyfer y defnydd arfaethedig
- 3.8 Fe atododd y swyddog rybudd penderfyniad ar gyfer y cais Cynllunio a wrthodwyd yn 2021, ac un o'r prif resymau dros wrthod oedd pryderon diogelwch y cyhoedd oherwydd prysurdeb y busnes a'r ffordd fawr.

3.9 Sylwadau Uned Gorfodaeth Cynllunio

- 3.10 Ymhellach i sylwadau gwreiddiol y gwasanaeth Cynllunio , fe dderbyniwyd sylwadau pellach a gwrthwynebiad gan y'r Uned Gorfodaeth yn nodi fod swyddogion yr Uned yn ymchwilio i mewn i dor-rheolaeth cynllunio ar y safle yn ogystal. Nodir fod y ddwy Uned Arlwyio symudol sydd ar y safle bellach angen caniatâd cynllunio gan eu bod wedi eu lleoli o fewn cwrtil adeilad Abersoch Land & Sea . Ni fu apêl yn erbyn y penderfyniad i wrthod caniatâd cynllunio ar gyfer Caffi – Bar ar y safle; ac felly noder fod y penderfyniad ar y cais yn sefyll, ac yn berthnasol i'r datblygiad diweddaraf.
- 3.11 Cadarnhawyd fod yr Uned yn y broses o gychwyn camau gorfodaeth ffurfiol i atal y defnydd di-ganiatâd cyfredol; er sicrhau fod yr unedau arlwyio symudol ynghyd ag unrhyw gyfarpar cysylltiol yn cael eu symud yn gyfan gwbl oddi ar y tir.

3.12 Sylwadau Uned Iechyd a Diogelwch Gwarchod y Cyhoedd

- 3.13 Derbyniwyd gwrthwynebiad gan yr Uned mewn perthynas a'r amcan trwyddedu o sicrhau diogelwch y cyhoedd. Nodwyd nad oedd unrhyw wybodaeth megis Asesiadau Risg wedi eu cynnwys gyda'r cais , er fod cyfeiriad at Asesiad Risg yn yr Atodlen Weithredol a gyflwynwyd.
- 3.14 Nodwyd nad oedd yr ymgeisydd wedi ystyried yn llawn oblygiadau diogelwch y cyhoedd mewn perthynas a gwerthu alcohol ar y safle. Datganwyd pryder fod potensial i nifer sylweddol o bobl ymgynnull tu allan i Abersoch Land and Sea, o dan ddylanwad alcohol; ac nad oedd unrhyw ystyriaeth i beryglon traffig ar y ddwy ochor i'r safle wedi ei gynnwys gyda'r cais.
- 3.15 Ymhellach, nodir nad oes eglurhad wedi ei gynnig o ran sut y byddai y busnes cychod Land and Sea yn rheoli risgiau diogelwch a r y safle tra bod alcohol yn cael ei werthu iw yfed ar y safle.
- 3.16 Mynegwyd pryder nad oedd unrhyw wybodaeth yn y cais ynglŷn a phryd y byddai goruchwylwyr drws yn cael eu cyflogi ; a sut y byddai disgwyl i staff reoli ymddygiad unigolion sydd wedi ymgynnull ger y safle wedi amser cau.

- 3.17 Fe gwestiynwyd beth yn union oedd yr ymgeisydd yn ei olygu gyda cynnal arolygon diogelwch rheolaidd; gan nad oedd unrhyw fanylion yn y cais na'r dogfennau cysylltiol.
- 3.18 **Sylwadau Uned Llygredd – Gwarchod y Cyhoedd**
- 3.19 Derbyniwyd sylwadau gan swyddog o'r gwasanaeth mewn perthynas a'r amcan trwyddedu o atal niwsans cyhoeddus. Noder fod trafodaeth wedi bod gyda chyfreithiwr yr ymgeisydd gan fod yr Atodlen Weithredol yn sôn am rheolaeth cerddoriaeth chwyddedig; er nad yw y cais yn gofyn am yr hawl i chwarae cerddoriaeth wedi ei recordio na cynnal cerddoriaeth fyw.
- 3.20 Mae cadarnhad wedi ei dderbyn nad yw yr ymgeisydd yn gofyn am yr hawl i gynnal adloniant rheoledig; ond nodir fod gan yr ymgeisydd hawl i chwarae cerddoriaeth o dan y Deddf Cerddoriaeth Byw 2012 os fydd y drwydded yn cael ei chaniatáu ar gyfer y safle. Fe gadarnhawyd mai'r bwriad fyddai chwarae cerddoriaeth ar lefel cefndirol yn unig. **Er hyn , gellir cadarnhau fod swyddogion y gwasanaeth wedi derbyn dau gwyn am sŵn o'r lleoliad dros benwythnos cyntaf i'r busnes fod yn masnachu bwyd ac alcohol ar Rybuddion Digwyddiad Dros Dro rhwng yr 8fed a'r 10fed o Orffennaf.** (Gwybodaeth yn gyfredol ar ddyddiad ysgrifennu'r adroddiad – 12/07/22)
- 3.21 Nododd y swyddog yn ogystal fod y cynllun yn dangos 12 o fyrddau sydd yn eistedd 8 person ar y safle, gyda lle i uchafswm o 96 o bobl i eistedd. Mae potensial felly oherwydd fod hwn yn safle agored i sŵn cwsmeriaid mewn grwpiau mawr , ac neu o dan ddylanwad alcohol i gario ; ac effeithio ar drigolion cyfagos. Mae ymddygiad a sŵn o'r fath mewn lleoliad agored yn anodd iawn i'w reoli.
- 3.22 **Sylwadau Uned Trafnidiaeth – Adran Amgylchedd**
- 3.23 Fe dderbyniwyd sylwadau a gwrthwynebiad i'r cais gan swyddog o'r Uned yn nodi nad oedd yr ymgeisydd wedi cyfarch unrhyw un o'r pryderon a nodwyd pan wrthwynebwyd y cais Cynllunio ar y safle am ddatblygiad cyffelyb yn 2021.
- 3.24 Yn benodol; cyfeiriwyd at y ffaith fod pryderon y byddai'r datblygiad arfaethedig yn debygol o ddenu nifer o bobl i ymgynnull yn agos i'r ffordd fawr , ac y byddai hyn yn effeithio ar welededd ar gyfer trigolion a chwsmeriaid yn gadael safle busnes cychod Land and Sea. Nodwyd fod cyfyngder y safle yn debygol o arwain at griwiau o gwsmeriaid yn ymgynnull o gwmpas y safle gan arwain at broblemau diogelwch y ffordd.
- 3.25 Ymhellach nodwyd fod diffyg parcio ar y safle yn debygol o achosi problemau parcio mewn llecynnau ar y ffordd fawr gan danseilio diogelwch cerddwyr a gyrwyr cerbydau.
- 3.26 **Sylwadau Cyngor Cymuned Llanengan**
- 3.27 Derbyniwyd sylwadau yn ymgorffori pryderon y Cyngor mewn perthynas a'r 4 amcan trwyddedu ac mae'r prif bwyntiau fel a ganlyn –
- **Atal Trosedd ac anrhefn** – pryderon y bydd yr hawl i weini alcohol 7 diwrnod yr wythnos tan 21:30 yn arwain at ymddygiad gwrthgymdeithasol a sŵn. Mae'r ddatblygiad tu allan i ganol y pentref mewn lleoliad tawel , gan effeithio ar gymeriad yr ardal
 - **Diogelwch y cyhoedd** – pryder fod cwsmeriaid angen croesi ffordd brysur i fynychu'r bwyty; ac fod y safle wedi ei leoli ar gyffordd brysur, ffordd mynediad i stadau tai, a dau fwyty arall. Nodir hefyd fod y datblygiad yn ychwanegu at brysurdeb prif weithgaredd y busnes , sef danfon a nol cychod o'r traeth gyda Tractors. Nid oes llecynnau parcio wedi ei nodi ar gyfer y bwriad ; ac mae pryderon y bydd mwy o bobl yn parcio ar linellau melyn ar

y ffordd gyfagos fel sy'n digwydd ar hyn o bryd gyda mynychwyr y ddau eiddo bwyd cyfagos.

- **Atal Niwsans cyhoeddus** – Pryder y bydd lleoliad safle bwyta arall mewn lleoliad gymharol dawel tu allan i brif gyrchfan y pentref ar gyfer bwyta a tafarndai yn achosi niwsans sŵn i drigolion. Ymhellach nodwyd pryderon am y potensial o sŵn i drigolion wrth i gwsmeriaid gyrraedd a gadael, ac wrth i'r busnes baratoi bwyd a chlirio ar ddiwedd y dydd.
- **Amddiffyn plant rhag niwed** - mae llawer iawn o blant a theuluoedd yn defnyddio'r lleoliad i fynd yn ôl ac blaen i'r traeth yn ystod y gwyliau. Nodwyd hefyd fod pryder oherwydd lleoliad safle bws ysgol gyferbyn a'r safle

3.28 Sylwadau trigolion lleol

3.29 Fe dderbyniwyd 7 o e byst gan drigolion yn gwrthwynebu'r cais am drwydded gyda pryderon mewn perthynas a'r pedwar amcan trwyddedu, ac yn benodol o ran anaddasrwydd y lleoliad o ran diogelwch y cyhoedd a'r potensial o niwsans cyhoeddus. Gweler isod grynodeb o brif bryderon y trigolion –

- **Atal Trosedd ac anrhefn** – pryderon y bydd yr hawl i weini alcohol 7 diwrnod yr wythnos tan 21:30 yn arwain at ymddygiad gwrthgymdeithasol a sŵn. Noder fod y datblygiad tu allan i'r brif ganolfan busnesau bwyd a diod yng nghanol y pentref; ac fod pryder y byddai hyn yn creu anhawster i'r Heddlu wrth geisio cadw rheolaeth ar drosedd ac anrhefn. Mae'r datblygiad mewn lleoliad tawel, gan effeithio ar gymeriad yr ardal.
- Roedd un ymatebydd yn cwestiynu sut oedd y Goruchwyliwr Eiddo Dynodedig yn gallu rheoli gweithgareddau trwyddedig ac yntau yn byw yn Aston Under Lyne.
- **Diogelwch y cyhoedd** – Noder fod dau drelar arlwyo, a dau gynhwysydd allforio wedi ymddangos ar y safle, er nad oedd hyn wedi ei gynnwys gyda Chynllun y cais. Amryw o'r ymatebwyr yn nodi fod y byrddau a chadeiriau wedi eu lleoli yn agos i'r ffordd fawr gyda dim ond wal derfyn isel rhwng yr ardal a'r ffordd. Llawer o'r ymatebwyr yn nodi pryderon gan fod y lleoliad ar gornel beryglus ar gyffordd rhwng y ffordd brysur A499 a Lon Garmon gyda mynediad i sawl busnes gan gynnwys busnes cychod Land and Sea yn ogystal a dau fwyty. Mynegwyd pryder fod mynediad a'r droed i'r lleoliad yn beryglus; ar gyffordd brysur ac fod Tractors yn mynd yn ôl ac ymlaen o'r lleoliad trwy'r dydd yn tynnu trelars a cychod yn ôl ac ymlaen i'r Traeth. Nodwyd fod plant yn cael eu denu i'r lleoliad i weld y Tractors a'r cychod.
- Datganwyd pryder fod Tractors yn rheolaidd yn symud trelars a cychod yn agos iawn i'r llecyn fydd yn cael ei ddefnyddio ar gyfer gwenni bwyd a diod i blant a theuluoedd; ac fod y pryderon hynny yn cynyddu oherwydd fod pobl yn yfed alcohol.
- Mae pryderon y bydd mwy o bobl yn parcio yn beryglus ar linellau melyn ar y ffordd gyfagos fel sy'n digwydd ar hyn o bryd gyda mynychwyr y ddau eiddo bwyd cyfagos.
- Datganwyd pryder y byddai cynnydd yn y ceir wedi eu parcio ar linellau melyn dwbl yn yr ardal gyfagos yn cynyddu'r risg y bydd mynediad argyfwng o'r adeilad Bad Achub RNLI yn cael ei rwystro
- Nododd sawl ymatebydd fod caniatâd Cynllunio wedi ei wrthod flwyddyn diwethaf ar gyfer Caffi Bar ar yr eiddo
- **Atal Niwsans cyhoeddus** – Nodwyd pryder gan bob un o'r ymatebwyr y byddai caniatáu trwydded ar gyfer y lleoliad awyr agored yn amharu ar drigolion cyfagos. Noder fod y lleoliad yn un gymharol dawel allan o'r brif rhan masnachol y pentref ac fod oddeutu 20 o breswylfeydd mewn lleoliad sensitif iawn i sŵn o'r eiddo.
- Ymhellach nodwyd pryderon am y potensial o sŵn i drigolion wrth i gwsmeriaid gyrraedd a gadael, ac wrth i staff y busnes baratoi bwyd a chlirio ar ddiwedd y dydd.

- Mae'r busnes wedi cychwyn masnachu ar Rybuddion Digwyddiad Dros dro ers dydd Gwener y 7fed o Orffennaf; ac nododd un ymatebydd ei fod wedi cael ei boeni gan fiwsig uchel yn cael ei chware ar y r eiddo nos Sul y 10fed o Orffennaf.

- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
