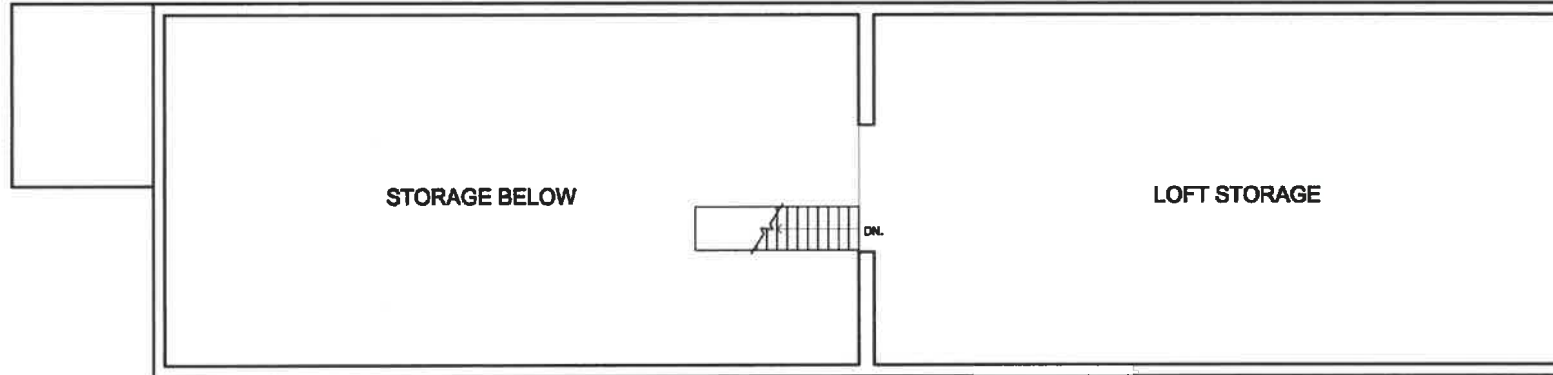

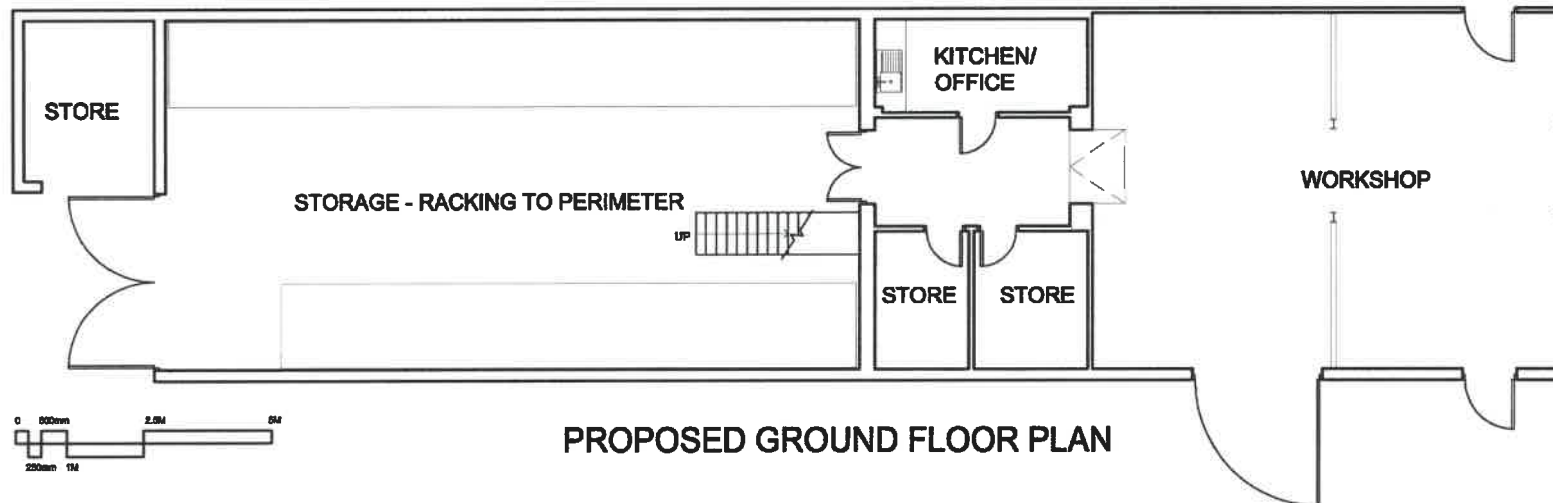

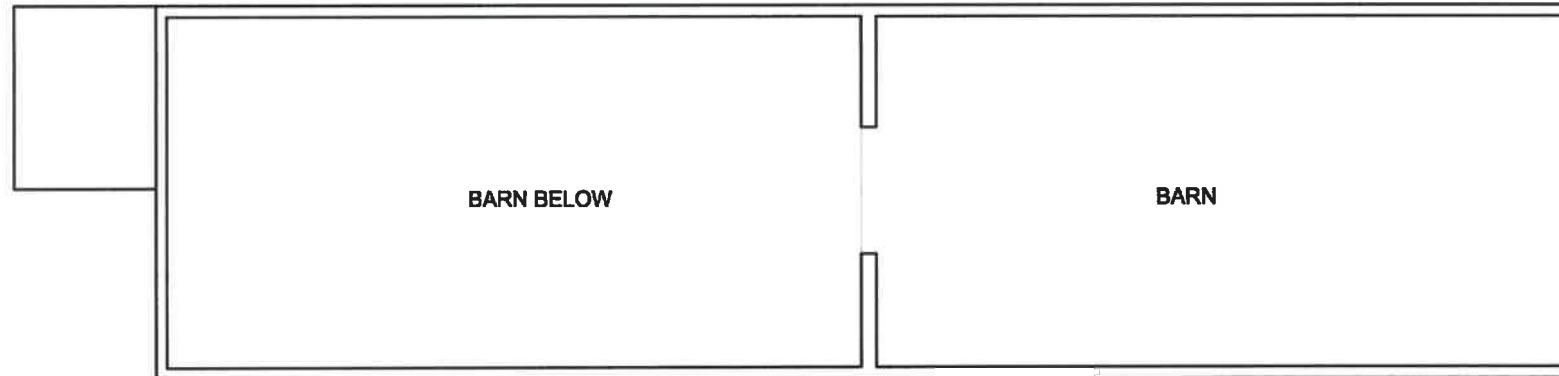

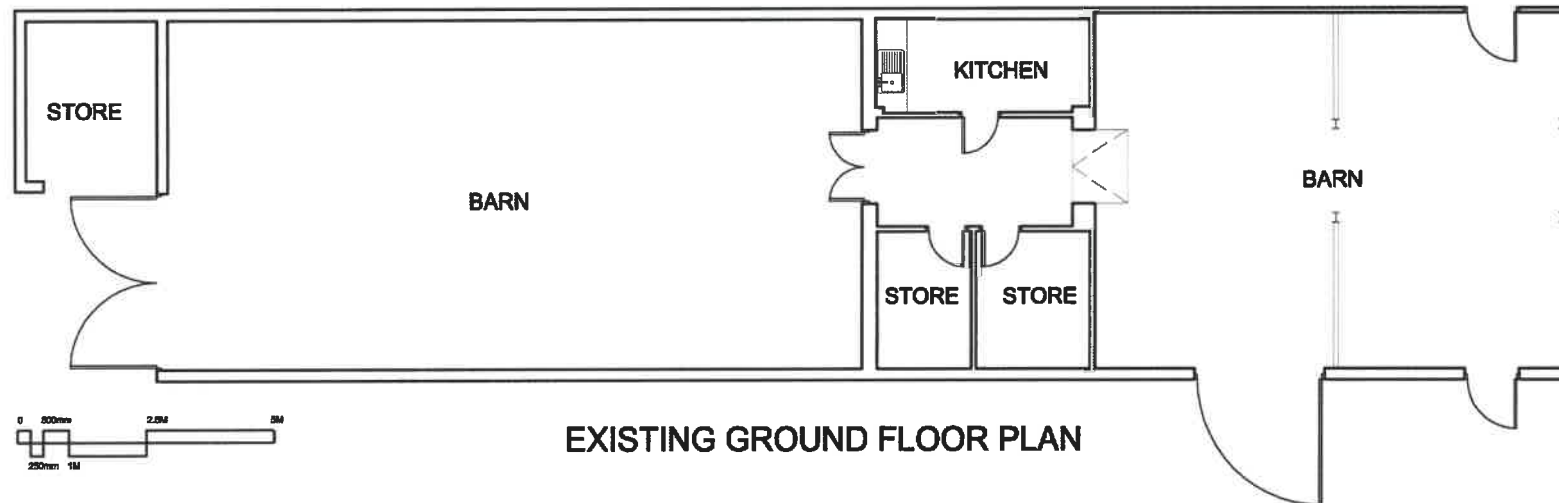
PROPOSED LOFT PLAN



PROPOSED GROUND FLOOR PLAN

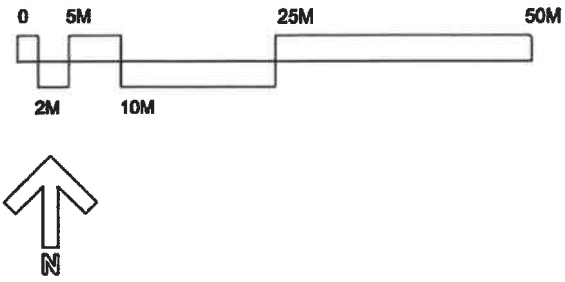


EXISTING LOFT PLAN
