Ers i'r cynlluniau ar gyfer ysgol gydol oes yn Y Bala gael eu datgelu, mae safbwynt llywodraethwyr Ysgol y Berwyn wedi bod yn ddigyfnewid – sef mai ysgol gyda statws gymunedol fyddai'n ateb gofynion addysgol a chymunedol yr ardal. Ysgol o'r fath fu Ysgol y Berwyn erioed – ysgol naturiol Gymraeg gydag ethos Gristnogol iddi. Dros y blynyddoedd mae'r ysgol wedi cyflanwi ei dyletswydd gyda chryn lwyddiant. Nid oes unrhyw ddadl addysgol wedi'i chyflwyno i gyfiawnhau newid y model yma. Mae wedi bod yn dderbyniol gan bawb o bob cefndir cymdeithasol a chrefyddol.

O roi statws Eglwysig i'r ysgol newydd byddai'n rhaid wrth bartneriaeth iach rhwng Cyngor Sir Gwynedd, yr Eglwys a'r gymuned leol. Yn anffodus, mae gohebiaeth ddiweddar o du'r Eglwys wedi creu ansicrwydd mawr sydd wedi arwain at amheuaeth wirioneddol ynghylch gallu partneriaeth o'r fath i redeg yr ysgol newydd yn llwyddiannus a chwbl ddiduedd. Gymaint yw pryder llywodraethwyr presennol Ysgol y Berwyn fel eu bod wedi datgan yn glir na allant wasanaethu ar gorff cysgodol yr ysgol newydd. Maent hefyd yn bryderus y byddai agor ysgol gyda statws Eglwysig yn erydu hawliau'r mwyafrif, gan nad oes dewis arall ar gyfer disgyblion uwchradd yn yr ardal. Yn ogystal, mae traean o ddisgyblion presennol Ysgol y Berwyn yn dod o siroedd Conwy a Dinbych. Mae perygl gwirioneddol i'r rhain droi eu cefnau ar ysgol gyda statws Eglwysig yn Y Bala gan fod ganddynt ddewis helaeth o ysgolion cymunedol y gallant eu mynychu yn siroedd Conwy a Dinbych.

Mae buddsoddiad Cyngor Sir Gwynedd a Llywodraeth Cymru yn un sydd wedi ei groesawu'n fawr yn ardal Y Bala. Er mwyn gwireddu'r cynllun i'w lawn botensial rhaid i lywodraethwyr yr ysgol newydd gael rhwydd hynt i redeg yr ysgol heb fod yn atebol i unrhyw gorff heblaw'r Cyngor Sir. Mae'n hanfodol hefyd iddynt gael cefnogaeth yr ardal gyfan, ond ar hyn o bryd, gwrthwynebiad cryf sydd yna i'r cynllun i agor ysgol gyda statws Eglwysig. Mae'r hinsawdd presennol yn creu ansicrwydd mawr ac yn ei gwneud yn anos gwerthu'r ysgol newydd i ddarpar rieni. Yn wyneb hyn, penderfynodd llywodraethwyr Ysgol y Berwyn ar Fawrth 7fed 2017 yn unfrydol (ar wahân i'r Cynghorydd Sirol, Dilwyn Morgan, a wnaeth ddatgan diddordeb ac atal ei bleidlais) i gefnogi cynnig i dynnu'r cynnig i sefydlu campws addysgu 3-19 oed gwirfoddol a reolir yn ei ôl. O wneud hyn, gall corff cysgodol yr ysgol newydd ganolbwyntio ar eu priod waith, sef sicrhau'r addysg orau i ddisgyblion dalgylch yr ysgol, gan groesawu pawb i ysgol sy'n eiddo i'r gymuned gyfan.

TRANSLATION

Ever since the plans for a lifelong school in Bala have been announced, the view of Ysgol Y Berwyn governors has remained the same - namely that a school with a community status would best meet the educational and community needs of the area. Ysgol y Berwyn has always been such a school – a Welsh school by its nature with a Christian ethos. Over the years, the school has delivered its responsibilities with considerable success. No educational argument has been put forward to justify a change to this model. It has been accepted by people of all social and religious backgrounds.

To give a religious status to the new school would require a healthy partnership to exist between Gwynedd Council, the Church and the local community. Unfortunately, recent correspondence from the Church has created great uncertainty that has resulted in genuine doubt about the ability of such a partnership to run the new school successfully and to be fully impartial. So much concern has been expressed by the existing governors of Ysgol Y Berwyn that they have made it clear they would be unable to serve on the shadow board of the new school.

They are also concerned that opening a school with a Church status erodes the rights of the majority, as there is no alternative for secondary school pupils in the area. In addition, a third of current Ysgol y Berwyn pupils are from Conwy and Denbighshire. There is a real danger that these will turn their backs on a Church school in Bala as they have a wide range of community schools they could attend in Conwy and Denbighshire.

The investment by Gwynedd Council and the Welsh Government is one that has been warmly welcomed in the Bala area. To realise the plan to its full potential, the new school governors need to be able to run the school without being accountable to any body other than the County Council. It will also be essential to have the support of the entire area, but currently, there is strong opposition to the plan to open a Church school. The current climate is creating great uncertainty and makes it harder to sell the new school to prospective parents. In view of this, on 7 March 2017 Ysgol Y Berwyn School Governors decided unanimously (apart from the County Councillor Dilwyn Morgan, who declared an interest and abstained from voting) to support a proposal to withdraw from the proposal to establish a voluntary controlled 3-19 learning campus. In doing so, the new school shadow body will be able to concentrate on their main task, namely to ensure the best education for pupils in the school's catchment area, welcoming everyone to a school owned by the entire community

Gwell ddatrys y sefyllfa drist hon rwan nag ymhen 2 flynedd.
- 2. Fel llywodraethwyr ysgol eglwysig, mae mewnbwn y gymuned ffydd Gristnogol leol (o bob enwad) i addysg ein plant yn bwysig i ni. Hoffem dderbyn sicrhâd y bydd modd anrhydeddu'r egwyddor hon, petai statws yr ysgol yn un gymunedol. Hoffem hefyd fynegi ein parodrwydd fel llywodraethwyr i gydweithio ac i sefyll ar gorff lywodraethol yr ysgol newydd boed yn ysgol eglwysig neu gymunedol.
- 3. Er ein bod yn cytuno bod rhaid adolygu'r statws eglwysig bellach, nid ydym yn gweld y cynnig presennol yn un boddhaol. Mae'r cynnig yn brin iawn o fanylion ac yn ymddangos yn risg ariannol sylweddol. Yr ydym yn poeni'n fawr am effaith oedi o leiaf blwyddyn i agor yr ysgol newydd ar morâl disgyblion a staff yr ysgolion presennol, ac yn enwedig am ddyfodol Ysgol Beuno Sant yn y flwyddyn ychwanegol. Rydym yn gweld cynnal ymgynghoriad arall yn wastraff o amser ac o arian gyhoeddus, gan bod dau ymgynghoriad tebyg wedi bod yn barod. - 4. Mae Ilithriad sylweddol wedi digwydd yn barod yn amserlen penodi arweinyddiaeth a staff yr ysgol ar gyfer agor ym Medi 2018. Yr ydym yn pryderu am ruthro'r broses hollbwysig hon ac yn gobeithio bydd unrhyw gynllun newydd yn caniatau digon o amser i'w chyflawni.
- 5. Hoffem fel llywodraethwyr fynegi ein siom a'n diffyg hyder yn y modd y mae'r Cyngor wedi cydarwain y brosiect, gan beri oedi diangen a thrafod materion yn gyhoeddus yn y wasg ddylai fod wedi eu datrys rhwng y Cyngor â'r Esgobaeth. Ysgol Beuno Sant Governors response to Gwynedd Council's proposal to withdraw the proposal to establish a VC Church in Wales Learning Campus in Wales at y Bala.

- 1. Our priority at Ysgol Beuno Sant is the pupil's well-being and education, and we wish to see a successful new school, where the pupils thrive both educationally and spiritually. We have experienced benefit and support from the school's close contact with the church and that is why we were ready to support the proposal to establish a school (with joint-denominational representation) under the voluntary control of the Church in Wales. However, as a consequence of the anti-church public statements and recent petition, the governors are now unanimous that it would not benefit our children to open a school with church status with the community showing such ill-feeling towards it. It is better to resolve this regrettable situation now than within 2 years.
- 2. As governors of a church school, the local Christian faith's input (from every denomination) to our children's education is important to us. We would like to receive assurance that this principle will be honoured. We also wish to state that we are ready as governors to co-operate and sit on the new school's governing body whether it be a church or a community school.
- 3. Although we agree that the church status requires further review, we do not regard the current proposal as satisfactory. The proposal contains very few details and it appears to be a substantial financial risk. We are greatly concerned about the impact of a delay of at least a year to open the new school and on the morale of pupils and staff at the current schools, and especially about the future of Ysgol Beuno Sant in the additional year. We regard holding a further consultation as a waste of time and of public money, as two similar consultations have already been held. It is probable that a period of uncertainty will lead to pupils being lost to Ysgol y Berwyn. We call on the Council to find a way to move the project forward as soon as possible. The children have already waited too long for their new school.
- 4. A substantial time slippage has already occurred in the time-table for appointing the school leaders and staff for the school's opening in September 2018. We are concerned about this crucial process being rushed and that hopefully any new plan will allow plenty of time to complete it.
- 5. As governors, we wish to express our disappointment and lack of confidence in the manner in which the Council have jointly led the project, causing unnecessary delay and discussing matters in public in the press, which should have been resolved between the Council and the Diocese. This has led to strong emotion that has split our community and caused much sadness and concern. Hopefully, future discussions will show grace, forgiveness and respect.

TRANSLATION

Ysgol Bro Tegid February 2_{nd}, 2017 Re Y Bala New Lifelong Learning School

Dear Mr Gareth Thomas,

As the Governing Body of Ysgol Bro Tegid, we were disappointed in the decision to designate a Church status to the new Lifelong Learning School following a consultation which came to an end in July 2015. We strongly believe that parents should be allowed to choose what type of education their children should receive, and by designating church status to the new school we are being deprived of this choice.

However, we were willing to accept the situation, subject to the agreement that it would be possible to re-assess the situation two years from the opening date of the new school.

The Church has since intervened in the process and have cause significant uncertainty locally regarding the future of the school. They have raised a question regarding the two-year clause in the letter dated September 9th 2016. We fear that this only provides a preview of further intervention by the Church in the education of our children once the school opens. This has re-opened the discussion and has shown us once again that the new school should be a community school.

Therefore, the governors of Ysgol Bro Tegid ask Gwynedd County Council to hold a new consultation, to review the status of the new school with the desire to have a community school that is not formally connected to any specific religious body.

Cadarnhaf nad oes gan y corff safbwynt penodol am 'statws' yr Ysgol Gydol Oes arfaethedig. Mae rhai aelodau yn credu y dylid cael ysgol gyda statws Gymunedol ac eraill yn amwys o ran y statws. Yr ydym yn unfrydol mai addysg y plant sydd bwysicaf. Yr oeddem fel corff yn edrych ymlaen i weld buddsoddiad hirddisgwyliedig yn denu ffrwyth gan fod yr Ysgol Uwchradd bresennol wedi dioddef o ddiffyg buddsoddiad ers blynyddoedd lawer. Y BALA LIFELONG LEARNING SCHOOL -SECOND CONSULTATION

I write on behalf of the Governing Body of Ysgol Ffridd y Llyn regarding recent events relating to the Lifelong Learning School for Y Bala catchment-area.

I confirm that the governing body has no specific viewpoint on the 'status' of the proposed Lifelong Learning School. Some members are of the view that there should be a school with a Community status and others are noncommittal as to the status. We are unanimous that it is the children's education that is of paramount importance. As a body, we looked forward to seeing a long-awaited investment bear fruit as there has been a lack of investment in the current Secondary School for many years. Consequently, we had supported a 'Church' status School with the aim of reviewing the status within two years.

Children in the Penllyn and Edyrnion area have had to wait for improvements to the education arrangements for much too long already, with confusion, and uncertainty always prevalent. When the most recent problems arose, with disagreement between the LEA and the Diocese regarding the School, it is a pity that a solution could not have been found through discussion rather than having a quarrel in public. It is a huge disappointment to have a further delay in the re-organisational process so that a Shadow Governing Body has not been formed, and that no steps have been taken to appoint a new Headteacher for the School. It was even more disappointing to see a quarrel arising between members of the community due to the lack of agreement, with public and media statements bordering on being extremely 'Anti-Church', including personal attacks, baseless allegations, and individuals being challenged to sign a petition and being placed under huge pressure to comply and sign. It is a source of regret that this was not avoided.

The implications of this possible change of direction has also been of concern to us at Ffridd y Llyn, with a suggestion made at one time that the re-organisational model would need to be re-considered and the possibility that this could undermine our discussions with Ysgol Bro Tryweryn regarding federation. Regarding this, we are grateful of having received your recent confirmation that the LEA continues to support these discussions and we look forward to proceeding.

I would like to amplify here comments made at the recent meeting held at Ysgol y Berwyn, for headteachers and chairpersons of governing bodies, on the impact that this has on pupils outside the county who attend Ysgol y Berwyn and pupils from this catchment-area who attend other schools. In recent years, an increasing number of pupils at Ysgol Ffridd y Llyn have gone on to attend Ysgol Bryn Hyfryd or Dinas Bran rather than Ysgol y Berwyn. It appears that this is due to various reasons, including the language spoken at home by the pupil, concerns about YYB's performance in the recent past, and a recognition that much better resources are available at the other schools, without having to travel much further. Initially, it appears that parents of non-Welsh speaking children tended to do this, but I have recently been surprised to hear parents that I would never expect to consider taking such a step stating the possibility - mainly due to a failure to find a solution at YYB and that they thought that it would be better to avoid the confusion of the re-organisation that has still not been resolved.

It is likely that whatever the LEA's decision whether or not to hold another consultation, that it will no longer be possible to keep to the time-table of appointing a lead structure of the Lifelong Learning School. It is a cause for concern to hear about the possibility of reducing the period allocated for appointing staff in order to try and establish the Lifelong Learning School as early as possible. The Lifelong Learning School provides an excellent opportunity, not only to improve the Schools' provision, resources and structure at Bala, but more importantly, to get the best possible leaders and staff there. We therefore request that the LEA ensure that appropriate time is allocated for that process, even if this involves having to delay the opening of the New School for a short period. After all, it is the Children's Education that is paramount – in the long term, and not to avoid embarrassment that the time-table has been delayed.

We would like a further assurance from the LEA on the future of the re-organisation process so that pupils, parents and staff in the area's schools receive hard facts about the situation from now on rather than rumour, allegations or accusations. It is important that we all know what is going on, to receive confirmation that a financial solution has

been found, and that the waiting for improvements to the educational provision comes to an end. If it is decided to hold another consultation, we earnestly hope that a further split within our community can be avoided and that a timely reconciliation is reached – with dignity and fairness.
